Bylaw No. 03-2014


A Bylaw to Fix the Rates to be Charged for the Use and Consumption of Water and to Fix the Rates to be Charged by Way of Rent or Service Charge for the Use of the Sewer.

The Council of the Village of Beechy, in the Province of Saskatchewan, enacts as follows:

1. All persons desiring to be supplied with water from the Village of Beechy's water supply system shall make application to the officials of the Village of Beechy. Each application shall be accompanied by the payment of a Utility Consumers' Deposit of \$200.00. The Utility Consumers' Deposit shall be refunded upon the closing of the said account or one year after the account is opened, whichever comes first, pending full payment of all accounts owing to the Village of Beechy, and providing the account has been kept current (no arrears) for 1 year (4 quarters). There will no longer be a meter deposit charged, and meter deposit refunds will be at the request of any person applying for the same, providing he/she has proof of payment of such deposit.
2. The fee for connecting (turning on) water service to a building (if the water was previously shut off) is \$50.00.
3. The Village of Beechy may ration or limit the amount of water furnished to any and/all consumers, should circumstances deem to warrant such action.
4. Water meters shall be read quarterly.
5. The charges to be paid by the water consumer whose water service has been connected shall be those set forth in Schedule "A" attached; provided, however, that the minimum shall be payable in every case, whether or not any water is consumed.
6. Persons who own or occupy premises drained, or that are required by bylaw to be drained, into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
7. Every customer shall pay a sewer and water capital surcharge, as set forth in Schedule "C" attached.
8.
 - a) Accounts for water service and/or sewer service shall cover a period of three (3) consecutive months, and shall be rendered on or before the first day of the month next following such period. If any account becomes in arrears (the previous quarterly billing has not been paid) the consumer be given thirty days (after the date of mailing of the water billing in which they became in arrears) to pay their arrears.
 - b) That, in the event the arrears have not been paid within thirty day of mailing of the water billing, a letter giving two weeks notice of disconnection be personally served upon those consumers.
 - c) That, in the event the arrears have not been paid within the two weeks notice, the water services be disconnected. When the water service is disconnected, it shall not be resumed until all arrears have been paid, together with a fee of \$50.00 to cover the expense of disconnecting and re-connecting the water, plus a refundable Utility Consumers' Deposit in the amount of \$200.00 will be required to be paid.

M-11 9) Bylaws 1-11 is hereby repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.
